

## PROHIBITED AND RESTRICTED MATERIALS POLICY

### 1. General Rule

Only approved, non-hazardous materials that are legally accepted by applicable landfills and disposal facilities may be placed in RO RO Rentals dumpsters. Customers are responsible for ensuring all materials comply with local, state, and facility-specific disposal requirements.

### 2. Prohibited Materials

The following materials are strictly prohibited and may not be placed in dumpsters under any circumstances:

- **Hazardous Materials**
  - *Toxic, flammable, explosive, corrosive, or otherwise regulated materials, including but not limited to paints (liquid), solvents, pesticides, fuels, oils, chemicals, propane tanks, compressed gas cylinders, fireworks, or ammunition.*
- **Electronics (E-Waste)**
  - *Electronic devices and components requiring specialized recycling, including televisions, computers, monitors, printers, tablets, phones, circuit boards, and batteries.*
- **Appliances with Refrigerants**
  - *Appliances containing refrigerants or cooling agents, including refrigerators, freezers, air conditioners, dehumidifiers, and water coolers.*
- **Tires and Automotive Materials**
  - *Automotive-related waste, including tires, car batteries, motor oil, antifreeze, engines, transmissions, fuel tanks, and similar components.*
- **Medical or Biohazard Waste**
  - *Materials contaminated with blood, bodily fluids, or presenting a biological or infectious risk, including needles, syringes, sharps, medical supplies, or biological waste.*
- **Asbestos and Regulated Building Materials**
  - *Asbestos or asbestos-containing materials, including insulation, floor tiles, pipe wrap, siding, roofing materials, or any suspected asbestos-containing debris.*
- **Liquids and Sludges**
  - *Free-flowing liquids or semi-liquid waste, including wet paint, chemicals, sludge, grease, or wastewater.*
- **Pressurized Containers**
  - *Pressurized or sealed containers, including propane cylinders, oxygen tanks, aerosol cans, and similar items.*
- **Unapproved Heavy or Dense Materials**
  - *Excessive quantities of dense materials that may exceed weight limits or landfill acceptance criteria, including concrete, brick, asphalt, cinder block, stone, or roofing shingles, unless prior approval is obtained.*

- **Any Material Prohibited by Disposal Facilities or Law**
  - *Any material that is prohibited, restricted, or rejected by applicable landfills, transfer stations, or local, state, or federal regulations.*

This list is not exhaustive. Materials deemed unacceptable by disposal facilities at the time of dumping are considered prohibited under this policy.

### **3. Restricted and Regulated Materials**

Certain materials may be subject to special handling, approval, or alternate disposal requirements and may not be accepted at all disposal facilities, including construction debris, mixed loads, or commercial waste restricted at residential or convenience facilities. Customers are responsible for verifying material acceptability prior to use.

### **4. Contaminated or Rejected Loads**

Loads containing prohibited or restricted materials may be classified as contaminated or rejected by disposal facilities. If a load is rejected, delayed, or requires special handling, the customer remains responsible for all resulting costs, delays, rerouting, unloading, or remediation required to lawfully dispose of the materials.

### **5. Fees, Fines, and Remediation Costs**

Customers are responsible for any fees, penalties, fines, cleanup costs, or additional service charges incurred as a result of prohibited or non-compliant materials. These charges may include, but are not limited to, additional hauling, disposal attempts, labor, downtime, or regulatory penalties imposed on RO RO Rentals.

### **6. Right to Refuse or Suspend Service**

RO RO Rentals reserves the right to refuse service, suspend hauling, or delay disposal if prohibited materials are suspected or identified. Service may resume only after the materials are removed or compliance is restored to the satisfaction of RO RO Rentals.

### **7. Customer Responsibility and Acknowledgment**

Customers are solely responsible for the contents of the dumpster. Booking a rental, authorizing service, or placing materials in a dumpster constitutes acknowledgment and acceptance of this Prohibited & Restricted Materials Policy.
